## \$1.14 Million Capital Raising

- **\$1.14m raised through Private Placement**
- **Funds to be used to advance existing exploration programs, provide working capital and to assess corporate opportunities**

Australian resources company GBM Resources Limited (ASX: GBZ) ("**GBZ**" or "**the Company**") is pleased to announce a \$1.14 million capital raising by way of a placement of 57,000,000 ordinary shares at 2 cents each.

The share placement has been completed, pursuant to the Company's 15% placement capacity under ASX Listing Rule 7.1.

The Company will issue a free attaching option, exercisable at 3.5 cents each and expiring 30 June 2016, for each share subscribed for in the share placement.
