Funds Raised Of \$268k Completes Balance of Placement Funds - Total Value of A\$1.8 million

GBM Resources Ltd (ASX:GBZ) (GBM or Company) is pleased to advise that it has raised a further A\$268,157 by the issue of 4,875,578 ordinary fully paid shares (Shares) at an issue price A\$0.055 per share, plus 2,437,789 options with an exercise price of A\$0.11 per share and expiry on 6 April 2023 (Options) to professional and sophisticated investors pursuant to the Placement.

The Company's recent Funding Activities also include:

- **Share swap to cement initial strategic partnership.** Novo Resources Corp (Novo) has issued 197,907 new fully paid ordinary shares to GBM. In exchange, GBM issued 9,090,909 Shares, plus 4,545,454 Options to Novo. The strategic partnership relates to the executed Agreement with Novo which comprises a Joint Venture and earn in option on the Malmsbury Gold Project in central Victoria.
- **EuroPac Gold Fund.** GBM issued 18,181,818 Shares at an issue price A\$0.055 per share, plus 9,090,909 Options raising approximately A\$1 million before costs in new equity funds (refer ASX release dated 31 March 2020 for both transactions).

The Company has finalised the issue of a total of 32,148,305 million Shares plus 16,074,152 Options.

Gross funds raised of approximately A\$1.8 million is made up of A\$1.268 million in cash and with shares in Novo, which are currently valued at A\$538k¹.

Peter Rohner, Managing Director and CEO, said:

"We are pleased to have completed this stage of our funding as it values the quality of the Company's mining assets in what is a very difficult and volatile market. The recent placements will support our strategy to accelerate development and exploration activities across our portfolio. We also believe the strategic partnership with Novo has the ability to rapidly unlock substantial value in goldfields of proven endowment, which the Malmsbury Gold Project represents in the central Victorian goldfields."

The issue of Shares and Options has been completed pursuant to the Company's 15% placement capacity under ASX Listing Rule 7.1 and the additional 10% placement capacity under Listing Rule 7.1A. Shares issued pursuant to the placement will rank equally with all other fully paid ordinary shares on issue.

The issue of 2,375,582 Shares and 1,187,791 Options in respect of the additional investor demand pursuant to the Placement was completed on 9 April 2020 (*refer Appendix 2A dated 9 April 2020*).

An Appendix 2A and Cleansing Notice regarding the issue of a further 2,499,996 Shares and 1,249,998 Options pursuant to the Placement is attached. The issue of the Shares and Options on the attached Appendix 2A completes the issue of securities pursuant to the Placement announced on 31 March 2020.
